F. Resolution – Elementary Demolition Compliance INDICATING COMPLIANCE WITH ORC 3313.41 RELATED TO DEMOLITION OF THE ORIGINAL ELEMENTARY SCHOOL BUILDING

WHEREAS, the Bath Local School District Board of Education (the "Board") is completing construction of a new elementary school building, through the Ohio School Facilities Commission ("OSFC") Expedited Local Partnership Program, and plans to demolish the existing elementary school, which will no longer be needed for school purposes, after completion of the new school; and

WHEREAS, the Board has determined that the original elementary school building is no longer needed for classroom purposes, and the Board plans to abate and demolish this building; and

WHEREAS, Ohio Revised Code Section 3313.41 includes requirements for disposal of a school building if there are start-up community schools within the territory of the school district; and

WHEREAS, there are no start-up community schools within the territory of the Bath Local School District to which the property must be offered for sale pursuant to Ohio Revised Code Section 3313.41(G) prior to disposal of the property by sale;

NOW, THEREFORE, BE IT RESOLVED by the Bath Local School District Board of Education as follows:

- 1. The original elementary school building is no longer needed for school purposes, and the Board has determined to proceed with the demolition of this building after completion of the new elementary school being built through the OSFC Expedited Local Partnership Program.
- The Board has complied with the provisions of Ohio Revised Code Section 3313.41 to the extent they are applicable to the demolition of this school building. There are no start-up community schools in the territory of the District.
