WHEREAS in alignment with our mission statement: "It is to educate all students to become responsible, caring, productive citizens and life-long learners by providing diverse and challenging learning experiences in a welcoming, safe and positive environment," AND

WHEREAS to ensure that all students can potentially better meet state performance indicators, AND WHEREAS all faculty and staff are focused on helping all students achieve to the best possible educational outcomes for all students in the least restrictive environment possible.

THEREFORE Be It Resolved, due to the COVID-19 pandemic, in addition to the Remote Learning Plan submitted to the Ohio Department of Education, the Board of Education directs the Superintendent to implement the following criteria for the 2020-21 school year effective immediately:

Criteria One: Any student in grades K-12 on a five day remote learning plan at home, that is not passing two or more subjects at the end of the first nine weeks, can be required to return to school in person full time beginning the second nine weeks.

Criteria Two: Any student in grades K-12 on a five day remote learning plan at home, that is not logging on and completing assignments as directed by their teacher, can be required to return to school in person full time at any time, at the discretion of the Principal.

Additionally, the Board of Education directs the Superintendent to develop administrative guidelines to implement the above criteria and to develop administrative guidelines to address similar issues with all students in relation to board policy JED on student attendance and board policy JFC on student conduct. REMOTE LEARNING: Remote learners are expected to log in daily and complete all assignments by the given due dates established by their teachers. Any online student in grades K-12 who is on a five day remote learning plan at home (Option 2) and is not logging in and/or completing assignments may be required to return to school full-time at any time as determined by the building principal. This includes, but is not limited to, online students who may be failing two or more classes or who have met the threshold of unexcused absences to be considered excessively absent (38 or more hours in a month or 65 or more hours in a year) or habitually truant per Ohio Revised Code.
