MEMORANDUM OF AGREEMENT

THEREFORE, the parties agree to the following:

- 1. The Internal Facilitator position will be filled on a year-to-year basis as funds are available as determined by the Board.
- 2. An annual salary of \$2,000.00 will be assigned to the Internal Facilitator supplemental position and paid with federal grant monies.
